- A. Suffolk County Council have submitted the pedestrian crossing points (new & improvements) to Mid Suffolk District Council's Economic Development team for consideration as part of Rural England Prosperity Fund a decision is pending.
- B. Following a full survey of road/traffic signage, a report on those which Suffolk County Council is responsible for has been submitted to the Highways team for action.
- C. The Parish Council has already approved CIL funding for the project of: £60,000
 - Spending approved to date: 3 x SIDs @ £10,000
 - Recommendation

The Parish Council approves moving forward with the following:

- 1. 40mph buffers budget £20,000, start with <u>approval of £1,035</u> for surveys to verify the roads are suitable. If Suffolk Highways state that the areas are suitable, the Parish Council will then request full breakdown of costs for remainder of project for final sign off.
- 2. Parking restrictions at junction of Queen Street & Church St & Parking Bays budget £15,000 (there is the potential to ask Highways to refresh other lines in the village at the same time cost to be confirmed).
- The remaining balance of allocated CIL funding: £15,000. A recommendation will follow at a later meeting and is dependent on outcome of bid to Rural England Prosperity Fund for crossing points.
